| Level | Name of Award                            | Value               | Award Description  |

| UG    | Bernadine Nightingale Scholarship        | Value: \$50 - \$250 | The Bernadine Nightingale Scholarship is awarded to a Year 4 BBA/iBBA student specializing in marketing who demonstrates strong academic potential. Non-OSOTF, both international and domestic students can apply.   |
| UG    | Bruno Amadi Bursary                      | Value: \$500        | Established through a gift from Bruno Amadi (BBA '79) to support a student who has completed the equivalent of at least one full year of the BBA/iBBA program with a minimum average of 6.00 (B) and a specialization in either finance or marketing. The recipient must be a Canadian citizen, permanent resident or protected person, an Ontario resident and demonstrate financial need. OSOTF, only domestic students can apply.   |
| UG    | Citi Canada Community Award              | Value: \$2,000      | Awarded to a second year BBA/iBBA student in the fall-term who has achieved a minimum GPA of 7.0 (B+) and demonstrates an interest in finance and extraordinary community involvement and engagement. Students must be Canadian citizens, permanent residents or protected persons, residents of Ontario and demonstrate financial need. This award is presented by Citi Canada in recognition of the firm's commitment to diversity and their support of women, aboriginals and persons with disabilities. Preference will be given to students in those three categories. With roots in Canada dating back to 1919, Citi has been operating in Canada continuously since the 1950s. Citi is one of the most global financial services organizations in Canada, with a presence on the ground in more than 160 countries and jurisdictions around the world. OSOTF, only domestic students can apply. |
| UG    | Class of '97 BBA Bursary                 | Value: \$500        | Each year a full-time BBA/iBBA student will be selected to receive the Class of '97 BBA/iBBA Bursary. The student selected will be in good standing, registered as a full-time student in the BBA/iBBA program. The recipient must be a Canadian citizen, permanent resident or protected person, an Ontario resident and demonstrate financial need. (OSOTF, only domestic students can apply).   |
| UG    | Devin Truax Memorial iBBA Scholarship    | Value: \$5,000      | Awarded annually to a full-time fourth year Schulich School of Business iBBA student who demonstrates academic excellence (minimum 7.50 GPA), financial need and a commitment to extracurricular volunteerism and community leadership.<br><br>This Scholarship has been established in memory of Devin Truax, who passed away suddenly and unexpectedly during the fourth year of his iBBA studies. This Scholarship reflects the values associated with Devin's time at Schulich, including his placement on the Dean's Honours List, his student government leadership and student ambassador roles, and his overall active involvement in the Schulich community. OSOTF guidelines, only domestic students can apply.  |
| UG    | Divakara Varma Memorial Award            | Value: \$1,100      | The Divakara Varma Memorial Award will be awarded to an undergraduate student entering third or fourth year of the BBA/iBBA program who demonstrates financial need. The student must have achieved a minimum 6.0 grade point average. The Divakara Varma Memorial Award was created by family and friends to commemorate the life of Mr. Divakara (Dik) Varma (1933-2017), a professional librarian for York University's Faculty of Administrative Studies and Public Services (1971-1994). Following retirement, he became a Senior Scholar (1994-2000). Non-OSOTF, both international and domestic students can apply.   |
| UG    | Ernst & Young BBA Award                  | Value: \$5,000      | In recognition of academic excellence, demonstrated leadership and financial need, Ernst & Young has created the Ernst & Young BBA Award. The award is given to Year 3 BBA/iBBA students who demonstrate academic excellence and leadership. Preference is given to students who are pursuing an accounting specialization. Recipients will have been active in their community and have demonstrated leadership either in student government or other extracurricular activities. Recipients must be Canadian citizens, permanent residents or protected persons, residents of Ontario and demonstrate financial need. OSOTF, only domestic students can apply.   |
| UG/GR | General Motors of Canada Limited Bursary | Value: \$1,000      | Students must be in the BBA/iBBA or MBA/IMBA program and must demonstrate financial need. Preference will be given to disabled students and then to students who have undergone personal hardship, such as the death of a parent, which resulted in financial hardship. Recipients must be Canadian citizens/permanent residents or protected persons, residents of Ontario and demonstrate financial need. OSOTF, only domestic students can apply.   |
| UG    | Gordon Charlton Shaw Achievement Award   | Value: \$250        | Awarded in the spring of the year to a graduating BBA/iBBA student. The student will have demonstrated satisfactory academic performance, and in the view of the awards committee, have made the most contribution to the School during their years in the Faculty. Non-OSOTF, both international and domestic students can apply.   |
| UG    | Gordon Charlton Shaw Award Fund          | Value: \$250        | Through the generous donation from Schulich professor Gordon Shaw, two BBA/iBBA students will receive bursaries to assist them in Year 2 or 3 of their studies. Recipients must have a minimum grade point average of 6.50. Recipients must be Canadian citizens, permanent residents or protected persons, residents of Ontario and demonstrate financial need. OSOTF, only domestic students can apply.  |

| UG    | Joshua Tan Memorial Scholarship                       | Value: \$350   | The BBA Class of 1996 has established this scholarship in memory of classmate Joshua Tan. The scholarship is awarded to a fourth-year BBA/IBBA student with a specialization in Finance who has achieved a minimum GPA of 7.0 (B+). Recipient must demonstrate financial need, compassion a sense of fairness and distinguished contribution in volunteer service. Non-OSOTF, international and domestic students can apply.  |
| UG    | Keun-Chang Kim Memorial Award                         | Value: \$1,250 | This award will be given to a Schulich School of Business undergraduate student with a minimum grade point average of 7.00 (B+) who is a Canadian citizen, permanent resident or protected person and resident of Ontario, and who demonstrates financial need. Preference will be given to students involved in an exchange program to Korea or who demonstrate a commitment to community volunteerism. This award can be given in addition to other exchange program funding. Young-Rahn Woo has established this award in loving memory of her father. OSOTF, only domestic students can apply.  |
| UG    | KPMG Undergraduate Scholarship                        | Value: \$7,500 | The KPMG Undergraduate Scholarship is established by the KPMG Foundation. This award will be granted to a fourth year BBA/IBBA student with a specialization in accounting. The successful candidate must demonstrate academic excellence, leadership skills and financial need. Non-OSOTF, international and domestic students can apply.  |
| UG    | Lawrence S. (Al) Rosen BBA Award                      | Value: \$1,000 | This Award is given to one third year BBA/IBBA student who demonstrates academic excellence, leadership and financial need. Preference is given to students who are pursuing an Accounting specialization. Recipients will have been active in their community and have demonstrated leadership either in student government or extracurricular activities. The student will demonstrate academic excellence and will be a Canadian citizen, permanent resident or protected person and resident of Ontario who demonstrates financial need. In recognition of academic excellence, demonstrated leadership and financial need, Al Rosen has created the Lawrence S. (Al) Rosen BBA Award. OSOTF, only domestic students can apply. |
| UG    | Maritime Life Award                                   | Value: \$1,000 | Awarded to a Year 3 student in the BBA/IBBA program, who have a minimum cumulative grade point average of 6.00 (B). Recipients must be Canadian citizens, permanent residents or protected persons, residents of Ontario and demonstrate financial need. OSOTF, only domestic students can apply.   |
| UG    | MBA Class of 2007 Schulich Ambassador Award           | Value: \$1,000 | The MBA Class of 2007 Schulich Ambassador Award is awarded to a full-time undergraduate student at the Schulich School of Business who demonstrates academic excellence, strong leadership and value-added judgment. Students must have a minimum 6.50 GPA and have completed a minimum of 50 hours in the Schulich Ambassador Program. The student must demonstrate financial need and be a Canadian citizen, permanent resident or protected person and a resident of Ontario. OSOTF, only domestic students can apply.   |
| UG    | Michael A. Katigbak Award                             | Value: \$500   | This bursary has been established through a gift from Michael A. Katigbak, whose focus is on complementary medicine. Awarded to a student with demonstrated financial need who is entering his/her Year 1 of the BBA/IBBA program. The recipient must be a Canadian citizen, permanent resident or protected person and an Ontario resident. OSOTF, only domestic students can apply.   |
| UG    | Michael Bond Memorial Award                           | Value: \$400   | Awarded to a fourth-year BBA/IBBA student based upon academic achievement. Student must demonstrate a special interest in the field of Operations Management and Information Systems or in the field of Marketing. Non-OSOTF, international and domestic students can apply.  |
| UG/GR | Michael Paul Sardella Award for International Studies | Value: \$2,000 | Established in memory of Michael Paul Sardella, who spent his last few years working in Southeast Asia, this award recognizes his passion for travel and the study of different cultures. It will be awarded to an undergraduate or graduate Schulich School of Business student to travel abroad for internships with foreign organizations, as part of their international program of studies. The recipient must have a minimum GPA of 6.00 (B+) and demonstrate financial need. Recipients must be Canadian citizens, permanent residents or protected persons who are residents of Ontario and demonstrate financial need. OSOTF, only domestic students can apply.  |
| UG    | Nicholas Gareri Award                                 | Value: \$500   | Awarded to a Year 1 BBA/IBBA student. Recipients must be Canadian citizens, permanent residents or protected persons, residents of Ontario and demonstrate financial need. OSOTF, only domestic students can apply.   |
| UG    | Stanley L. Warner Memorial Award (Schulich)           | Value: \$266   | Awarded to recognize a Year 3 or 4 BBA/IBBA student's academic achievement and extracurricular activities or contribution to the community and/or university life. This award was established in memory of Stanley L. Warner, Schulich professor of statistics and economics, to celebrate his many contributions to the School and his field. Non-OSOTF, international and domestic students can apply.  |
| UG    | The Aleksander Shved 50th Anniversary BBA Bursary     | Value: \$1,000 | The Aleksander Shved 50th Anniversary BBA Bursary is established by Schulich alumnus Aleksander Shved (BBA '11) and will be awarded to a first year BBA student enrolled in the BBA program, who demonstrated financial need. Non-OSOTF, international and domestic students can apply.   |

| UG/GR | The Isaac Akande Scholarship Trust Fund                                 | Value: \$1,000                       | This Scholarship was created by the Family of Dr. Isaac Akande, an optometrist who often spoke of the need to encourage young members of the black community to pursue business as a career. The Scholarship will be awarded annually to a student entering Year 1 of the BBA Program or the full-time MBA Program. The successful candidate must have achieved academic excellence to date (minimum B+ average), demonstrated financial need, and must be able to demonstrate through a short essay their involvement in extra-curricular activities within the Black or wider community. Non-OSOTF, international and domestic students can apply.  |
| UG    | The James Bray Bursary in Memory of Mrs. Anne Bray                      | Value: \$500                         | This award is open to all BBA/iBBA students at the Schulich School of Business. Recipients must be Canadian citizens, permanent residents or protected persons, residents of Ontario and demonstrate financial need. OSOTF, only domestic students can apply.   |
| UG    | The Peterson Family Gold Medal & Scholarship in Entrepreneurial Studies | Value: \$1,500 including gold plaque | The Peterson Family Gold Medal & Scholarship in Entrepreneurial Studies is awarded to a graduating undergraduate student who has pursued the Entrepreneurial & Family Business Studies concentration and achieved the highest academic standing in the concentration and also demonstrates true entrepreneurial spirit and drive. Non-OSOTF, international and domestic students can apply.   |
| UG    | Thomas H. Beechy Award for International Exchange                       | Value: \$1,000                       | This award is available to a second or third-year BBA/iBBA student who intends to participate in an academic exchange, demonstrates financial need, and has achieved a minimum 6.0 (B) in Schulich courses. OSOTF, only domestic students can apply.  |
| UG    | Toronto Dominion Bank Award   | Value: \$3,000                       | Available to students registered in Year 3 or 4 of the BBA/iBBA program. Successful candidates must have a minimum grade point average of 7.00 (B+). Recipients must be Canadian citizens, permanent residents or protected persons, residents of Ontario and demonstrate financial need. OSOTF, only domestic students can apply.  |
| UG/GR | Women in Leadership Student Award                                       | Value: \$1,000                       | The Women in Leadership Student Award has been established by the Women in Leadership Student Association at the Schulich School of Business. It will be awarded annually to a continuing female undergraduate or Master's level student enrolled in the BBA/iBBA or MBA/IMBA program. The recipient must demonstrate high academic achievement (minimum GPA of B+) and strong leadership abilities. Preference will be given to a student who demonstrates significant financial hardship.
